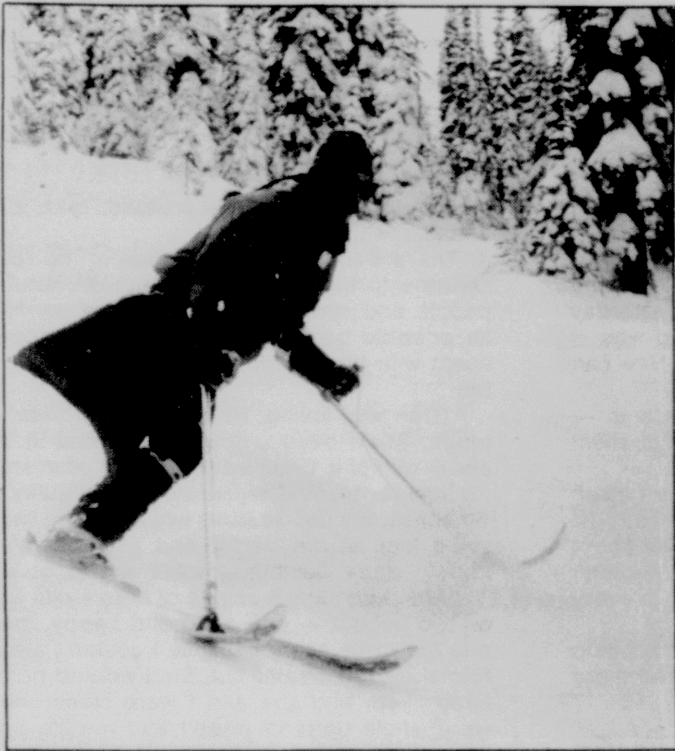

Volunteers help the parent move towards recognizing their own needs, develop their strengths and utilize community resources. They make a year's commitment to see a family regularly for an average of 2 to 4 hours a week. Volunteers participate in an initial 16 hour training program, they then receive on-going training and regular group supervision with other parent aide volunteers.
